# **Practice**

He appears regularly before all levels of court in Ontario, including Small Claims Court, the Ontario Court of Justice, the Superior Court of Justice, Federal Court and the Ontario Court of Appeal. Daniel also appears before a number of administrative tribunals, including the Ontario Securities Commission, the Investment Industry Regulatory Organization of Canada, the Real Estate Council of Ontario, the Landlord and Tenant Board and the Human Rights Tribunal of Ontario.

Daniel also has considerable experience in achieving results for his clients without the need for lengthy and expensive litigation. He has acted as counsel in many mediations, arbitrations and negotiated settlements, recognizing that the best resolution often involves creative and practical solutions.

Daniel's practice is focused on high-level real property litigation. His main areas of expertise include real property disputes involving the purchase and sale of large commercial property and commercial lease disputes.

His practice extends to construction litigation, construction lien work for developers and individuals, large debt collection matters, including commercial rent arrears and mortgage enforcement work. Daniel also has experience in securities litigation and regulatory work, such as disputes involving mergers and acquisitions, plans of arrangements, hostile take-overs, proxy battles, Securities Act applications, broker negligence and shareholder disputes.

Daniel's career highlights include:

- successfully representing a large commercial landlord before the Ontario Court of Appeal in the termination of a multi-million lease for GoodLife Fitness:
- representing multiple defendants in a precedent-setting summary judgment decision for the successful dismissal of a \$37 million claim pertaining to a series of complex real estate transactions; and
- representing multiple financial institutions in hundreds of complex mortgage enforcement proceedings before the Superior Court
  of Justice and the Ontario Court of Appeal, including the Bank of Nova Scotia, CIBC Mortgages Inc., First National Financial
  Corporation, Deutsche Bank AG and Street Capital Financial Corporation.

Daniel previously spent over five years as a commercial litigator at a mid-sized Toronto firm and at one of Canada's largest full-service law firms. Before going to law school, Daniel was a journalist for different media outlets, including the Canadian Broadcasting Corporation in London, England and the Associated Press in Jerusalem, Israel.
